Friendly Reminder: The California Highway Patrol (CHP) can and will issue tickets within Lake California. There seems to be some confusion in the community that because we are on community-maintained roads that the CHP cannot issue citations. This is incorrect. All roads within Lake California are subject to California State vehicle / traffic regulations and this is specified in California law, the community rules booklet, and also stated on the sign as you enter the community prior to the gate entrance. You should expect to see increased CHP presence in the community based on recent community concerns expressed to CHP. CHP was here issuing citations last week and will continue to periodically perform traffic enforcement. **Residents are encouraged to report traffic concerns to CHP using 911 if it is an emergency, and using 530-527-2034 for non-emergency concerns.**

Lake update: Based on our water contract limitations there will be a limited amount of water in our lake this summer. We have treated the lake 4 times this year already but due to the heat of summer months there could be more vegetation.





The Lake California Property Owner's Association Swimming Pool Rules

The Lake California Property Owner's Association Swimming Pool is a privately-owned recreation entity, entirely funded by annual assessment paying members. The LCPOA Board of Directors administers the Pool Rules and Regulations. Day to day management of the pool is the responsibility of the POA Management. Membership and use of the pool is a privilege extended to property owners whose annual dues are current and paid in full. Eligible adult(s) must complete a registration form providing basic data for identification of individual family members authorized to use the pool. Registration indicates that members understand and agree to abide by the rules and regulations governing safe and lawful operation of the swimming pool and assume responsibility for all dependent minors and/or guests using the pool facilities. Pool passes will be issued upon receipt of registration forms.

*****THERE IS NO LIFEGUARD ON DUTY – SWIM AT YOUR OWN RISK*****

RULES

- Normal Pool hours are from 10:00 AM until 9:00 PM. Adult swim is Monday – Fridays only between 7-10 AM. However, pool hours may be adjusted by POA management.
- **The Pool is for residents only.** Guests' must be accompanied by a resident who is 18 years or older. Violators will be asked to leave the Pool area.
- Please ensure the gate closes properly behind you when entering/exiting to ensure that the locking system will activate.
- Pool attendant may be on-duty to supervise and enforce pool rules.
- Children under 14 must have adult supervision at all times.
- Appropriate swimwear required. No street clothes.
- All persons should shower prior to entering the pools, and after applying lotion before re-entering the water.
- Floatation devices are not allowed in the pools. Only small children/infants may wear, arm floatation bands, floatation vests or infant floatation seats.
- Children's wading pool for children 7 years and younger.
- All infants must wear a swim diaper at all times. No regular diapers are allowed in the pool.
- No running or horseplay in or around the pool area.
- No loud, abusive, or foul language.
- No food or drink in the pool.

- Audio equipment may be used in the pool area if kept turned low as not to disturb others. Patrons agree to remove radio, or use earphones if complaints are made.
- No glass or breakable objects permitted in the pool area.
- No smoking within the pool area. Smoking is allowed outside the gate.
- No pets allowed in the pool area, except for Service Dogs only.

The Pool Attendant is given full authority to enforce all swimming pool regulations as needed to maintain the safety of members and their guests. Appropriate behavior and cooperation is expected by all members and their guests.

ANYONE not following rules while at the pool will be given warnings as follows:

- **1st Offense** - verbal warning
- **2nd Offense** - out of the pool for 30 minutes
- **3rd Offense** - asked to leave the pool for the day (if offender is under 18, the offender's parents will be notified.)
- **4th Offense** (upon returning to pool) - out of the pool for a week (if offender is under 18, the offender's parents will be notified.)
- **Extreme violations such as/but not limited too; threats, violence, obscene behavior, defecation in the pool, physical harm to another party, etc. may result in immediate suspension for the rest of the pool season.**

All warnings will be documented with the exception of 1st Offense, which will result in a verbal warning.

- **Lightning Policy** - In the event that lightning, or thunder is present, please exit the pool and remain out of the pool until 30 minutes past the last visible lightning strike or episode of thunder.
- POA Manager has the right to impose additional rules to ensure the safety and well-being of all pool users, as well as remove anyone from the pool facilities for not following pool rules.
- LCPOA is not responsible for injuries or lost/damaged articles.
- Incidents and Accidents should be reported to the Pool Attendant immediately so that a report can be filled out.
- The Pool Attendant is authorized to immediately expel violators from the pool area.

VIOLATION OF THESE RULES MAY RESULT IN LOSS OF PRIVILEGES.

The View from the Street

As there are many residents that are new to the community and may be new to storing their equipment at the LCPOA RV Storage Facility; and with the paving project that is tentatively scheduled for late August 2022 we would like to go over the requirements regarding use of the portion of Common Area known as the Lake California RV Storage Facility.

Being able to rent a storage space in the LCPOA RV Storage Facility is a privilege afforded to Property Owners, (or their residents) who are “good standing” with the Association and comes with certain requirements and specified standards that must be complied with.

The Lake California Governing Documents **Article 8, Subsection 8.3** states that *"All use of Common Area is subject to the Governing Documents. Without limiting the generality of the foregoing, no alterations or additions to the Common Area shall be permitted without the prior written approval of the Board; nothing shall be altered, constructed, placed, kept, stored, parked, planted on, or removed from the Common Area without the prior written consent of the Board; and the Common Area shall be kept free of rubbish, debris, and other unsightly or unsanitary materials. Each Owner shall avoid causing any damage to the Common Area."*

The required written consent of the Board is that which has been established within the **RV Storage Rental Agreement** that is entered into by the Property Owner/Tenant and the LCPOA.

Section 4 of the agreement **Use of, Access to, and Condition of RV Storage Space** states in part that the *"Tenant agrees to use the RV Storage Space only for the storage of the recreational vehicle(s), boats, trailers, campers, or other property designated in Exhibit-A."*

"For stored vehicles/vessels that are subject to DMV or equivalent regulation in any state, Tenant agrees to provide LCPOA with copy(ies) of current registration(s) and any renewal(s) thereof (whether the vehicle/vessel is operative or "non-op)." It is also stated that "No refuse or debris of any kind shall be permitted to accumulate in or around the stored property or the RV Storage Space."

Also, in the Lake California By-Laws **Article 6.2 (c) Restriction on Lessor's Use of Recreational Common Areas**, it is stated that *"During the period of any lease or rental of a Lot, any Owner not residing within the Development shall not be entitled to use the recreational Common Areas except to the extent necessary to perform the usual responsibilities of a landlord or to ensure or gain compliance by the tenant with the requirements of the Governing Documents."*

The RV Storage facility is not intended for the storage of broken-down inoperative unusable equipment or other miscellaneous items.

It is intended to provide members residing in the community with a place for the storage of their currently registered and regularly used recreational vehicles such as boats, trailers, campers, etc. which cannot be properly stored at their property in accordance with community rule RR-06-20 PARKING.

LCPOA Management will as needed review rental space agreements for the possible removal of equipment belonging to those who have allowed any stored equipment to deteriorate into an unusable and unsightly condition, so please be sure to maintain all portions of any of the Common Areas used by you in a clean well-kept and attractive condition.

DID YOU KNOW:

Reducing waste at home is easy! You'll save money and prevent your garbage and recycling carts from filling up too quickly before your next collection day. You'll also help the County conserve landfill space, which is good for everyone. Try these tips to reduce waste at home:

When you shop hungry, you're more likely to over-purchase food. Finally, keeping track of the foods you do throw out can help. For example, if you buy a big bag of potatoes and some go moldy, make a note to buy fewer potatoes next time. Billing Updates: DELINQUENT CHARGES AND WATER LOCK OFFS FOR NON-PAYMENT HAVE BEEN REINSTATED EFFECTIVE JANUARY 1, 2022. Metered customers billed for the period 03/ 01/22 to 5/3/22 on May 3, 2022, are due and payable by June 6, 2022, to avoid delinquent charges. Customers that have not paid their previous balances (billing period 1/1/22-3/3/22) or signed payment arrangement contracts are scheduled for lock off on June 6, 2022. Availability lot billings for the period 4/1/22 through 6/30/22 will be mailed out on June 30th. Payments can be made by check or cash, and credit card payments can be made on our website at www.RAWD.org. Customers can also sign up for auto draft payments by completing the form found on our website or at the District office.

Drought: The severity of the drought can be seen in May's last three years of precipitation and lake levels:

Year	May Precipitation Received	Average Precipitation to Date	Percent of Average	Shasta Lake feet from Crest
2022	17.95	31.43	57%	120.34
2021	13.27	29.80	48%	89.29
2020	21.43	32.19	57%	34.91

If you are planning on removing your turf, we recommend waiting until the state budget is passed. We are hoping they approve the turf removal funding. We will keep you posted when we hear more. Consumption for the billing period 3/3/22 through 5/3/22 was down 9.4% but the year to date was up 4.6% in comparison to 2013 numbers. We are currently on voluntary restrictions, but I expect it to become mandatory. In fact, the state water board will be considering drought related emergency water conservation regulation at its May 24th meeting. Please do everything you can to save water, we are all in this together. The final snowpack survey held on April 29th in the Sierra Nevada Mountains found no measurable snow. **Most likely** we will be returning to restricted watering days, and we will keep you posted if/when that becomes mandatory. Please take the time to check your irrigation system for leaks and missing heads. Visit saveourwater.com for conservation ideas and water-wise techniques or stop by the District for literature on water saving and drought resistant plants.

New Construction: At the request of Rio Alto, the POA AC Committee has included **restrictions on planting red-wood trees and oleanders within 25 feet of District water and sewer lines on new builds.** No planting should be done in easements where water, sewer, electric, phone and cable utilities are located.

Wetlands Update: Thanks to all of you that attended the community meeting we held regarding dogs off leash at the wetlands. We received a great deal of valuable input to help resolve the issue. The District has ordered a keycard reader for the entrance to the wetlands. Once installed, residents will be able to obtain a card from the District by signing a contract and paying a non-refundable deposit. We will also be installing a solar powered camera to monitor the facility. Wetlands walkers can forward cell phone pictures to the District through email. District staff will then be able to review the pictures and deactivate the cards of residents not complying with the rules.

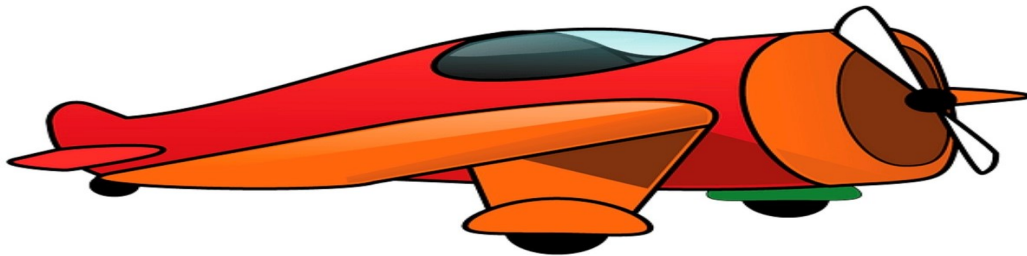

Facts about *Naegleria fowleri* and Primary Amebic Meningoencephalitis

Naegleria fowleri is found around the world, often in warm or hot freshwater (lakes, rivers, and hot springs).

Naegleria fowleri infections are rare and devastating. From 2010 to 2019, 34 infections were reported in the U.S. All but three were fatal.

- *Naegleria fowleri* is a warm water-loving amoeba found around the world, often in warm or hot freshwater (lakes, rivers, and hot springs).
- *Naegleria fowleri* amoeba can travel up the nose and into the brain. This causes the disease primary amebic meningoencephalitis (PAM), which destroys brain tissue and causes brain swelling and death.
- Of 148 people known to be infected in the U.S. since 1962, only four people survived.

Symptoms can be mild at first, but they worsen quickly.

- Usually start about 5 days after infection (but can range from 1–9 days)
- Can include headache, fever, nausea, or vomiting
- Later symptoms can include stiff neck, confusion, lack of attention to people and surroundings, loss of balance, seizures, and hallucinations
- After symptoms start, the disease causes death within about 5 days (but can range from 1–12 days)

You **cannot** be infected with *Naegleria fowleri* by drinking contaminated water, and the infection cannot spread from one person to another.



Infections are contracted through the nose.

People are infected when water containing the amoeba enters the body through the nose. Infections are most often associated with swimming or diving during the summer in warm freshwater, such as lakes and rivers. Sometimes infections occur after people put their head under water in hot springs.


Infection has also happened when people use contaminated drinking water to cleanse their nasal passages during religious practices, use a neti pot or other device to rinse their sinuses through the nose, or get the contaminated water up their nose during recreational play.
